2. Purpose and Scope

This Declaration of Origin Statement is issued by UPCOM for use in customer, tender, commercial and technical documentation where a company-level origin statement is requested for UPCOM supplied products.

The declaration applies only to products specifically supplied, invoiced or documented by UPCOM. The actual country of origin for each product or shipment shall be the origin stated in the relevant commercial invoice, packing list, delivery document, product label, datasheet or product-specific declaration, where applicable.

3. Product Groups Covered

- Rack cabinets, indoor/outdoor enclosures, ODF cabinets and passive metal accessories
- Fiber optic cables and Data LAN cables
- Cable blowing machines and machine-specific accessories
- Fiber and copper passive connectivity products, assemblies and accessories
- PDU, fan units, thermostats, lighting kits, cooling units and other powered accessories where supplied by UPCOM

4. Origin Statement

Origin Declaration

UPCOM declares that, for the products and shipments specifically supplied under UPCOM commercial documents, the country of origin shall be the origin stated in the relevant invoice, packing list, delivery document or product-specific declaration. Products declared as Türkiye origin are supplied on the basis of available production, assembly, supplier and/or traceability records held by UPCOM. This statement is issued for commercial, technical, tender and customer documentation purposes.

5. Product Group Origin Handling

Product group	Origin statement handling
Rack cabinets, indoor/outdoor enclosures and passive metal accessories	Declared as Türkiye origin where manufactured, assembled and supplied by UPCOM or its approved production network in Türkiye.
Fiber optic cables and Data LAN cables	Declared according to the actual product/order origin and supporting production or supplier documentation.
Cable blowing machines and machine-specific accessories	Declared according to the actual model, configuration and product/order origin.
Fiber and copper passive connectivity products	Declared according to the actual product/order origin and supporting supplier or production documentation.
PDU, fan units, thermostat, lighting kits, cooling units and powered accessories	Declared according to the actual component/product origin shown in the relevant commercial documents or supplier documentation.

6. Conditions and Limitations

This declaration is based on UPCOM commercial records, product documentation, supplier documentation, production or assembly information and/or internal traceability records available at the date of issue.

- This document shall not be used to claim preferential customs origin unless a separate preferential origin document has been issued by the competent authority or valid supplier declaration procedure.
- For mixed-origin shipments, bundled products or products including third-party electrical/electronic components, the declared origin may vary by product line, component or shipment item.
- Where an official certificate of origin is required for customs clearance, banking, letter of credit or import regulation purposes, the relevant official document must be obtained separately.
- This declaration does not override the country of origin stated on the invoice, packing list, product label, customs document or product-specific declaration.

Important note: This document is a company declaration of origin statement. It does not replace an official Chamber of Commerce Certificate of Origin, customs authority certificate, EUR.1, ATR, supplier declaration for preferential origin or any other official trade document where such document is required by the destination country, customer, bank, customs broker or customs authority.
